Joint Africa-EU Strategy: a new shared vision

The Strategy is inspired by a new vision, moving the EU-Africa partnership:

- **beyond development** elaborating a real political partnership
- **beyond Africa** building a global partnership
- **beyond institutions** launching a people-centred partnership
- **beyond fragmentation** treating Africa as one



Africa – EU Strategy

- Facilitate and promote a people-centred partnership

= 1 of the 4 key objectives of the Strategy



In the Strategy : A people- centered Partnership


Africa and Europe's women, men and children should be part and parcel of this new partnership:

- Broad-based consultation over one year in the run up to Lisbon
- Build a permanent platform for dialogue and implementation
- Promote cooperation between CSO (ia: Promoting twinnings)




What role for research?

“.... And European and African research institutes and think tanks will participate in dialogue mechanisms and initiatives and play a key role in monitoring the implementation of African, European and joint policies and commitments outlined in the Joint Strategy”



First Action Plan 2008-2010 - Making it work: institutional architecture and implementation (1)

- Establish a **mapping** of existing European and African civil society networks;
- Establish a platform for European and African **research institutes and think tanks** to provide independent policy advice;
- Create a **web portal** to facilitate consultations with civil society organisations (CSOs) ahead of key policy decisions;



First Action Plan 2008-2010: Making it work: institutional architecture and implementation (2)

- Invite representatives from European and African **civil societies** to express themselves ahead of Ministerial Troika meetings (biannual) – produce reports on implementation;
- Establish planning and priority setting mechanism for future Action Plans;
- Establish informal **joint expert groups** on all priority actions identified in the Action Plan



Build synergies with the **EU Research Initiative** - Objectives

Develop and express a European perspective
on strategic issues in development:

- Feeding the intra-EU debate
- Improving visibility of European thinking
- Helping shape the international agenda



Output & Process

- Output of the Initiative: *European Report on Development (ERD)*, an annual research-led review of development issues and a European counterpart to other major flagship global reports (first to be published in 2008) aimed at bridging the gap between researchers and policy-makers
- Process of consultation: March 2007 first research workshop with the purpose of identifying multi-year story line for ERD

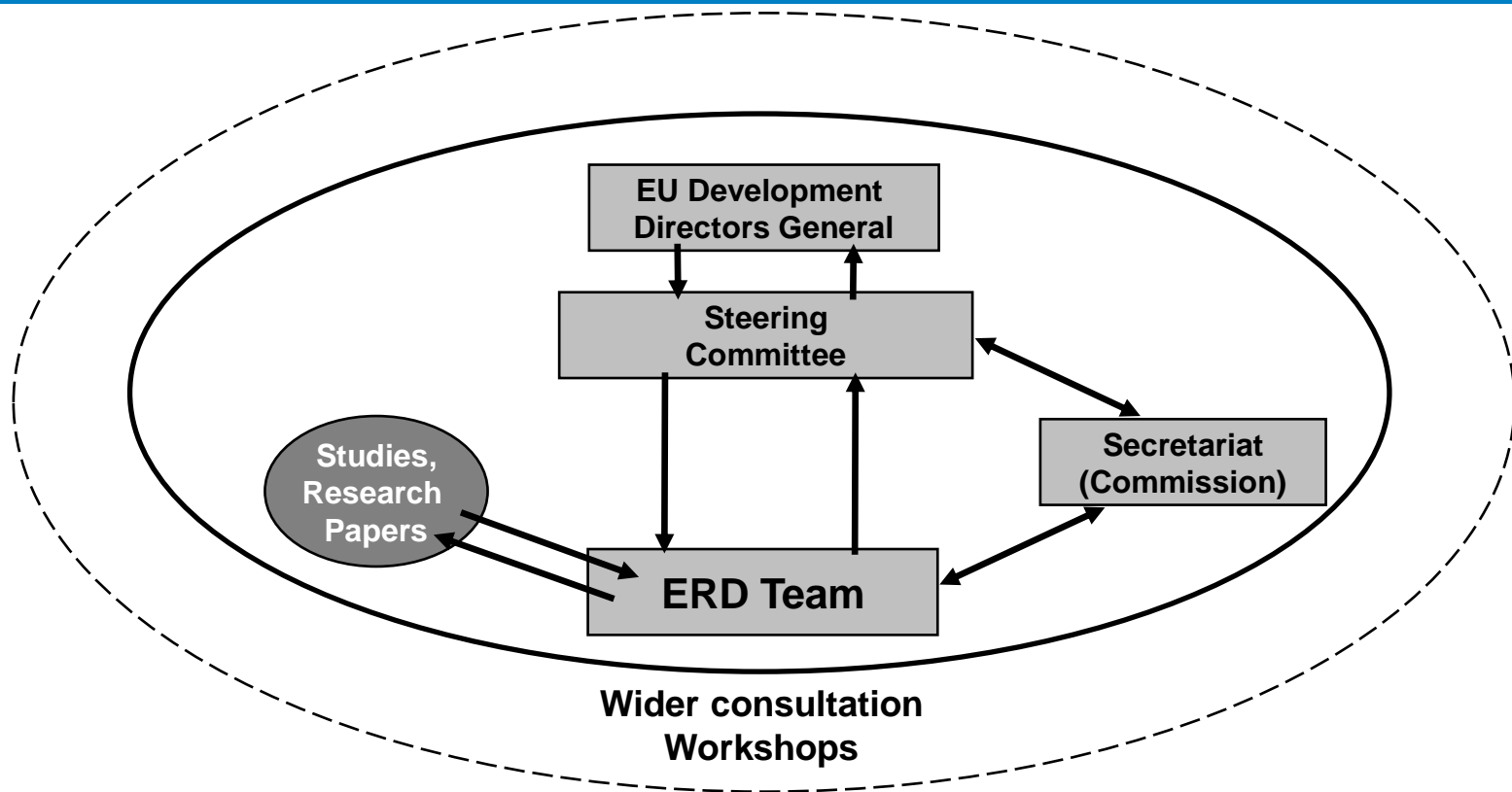


Multi-Year Story Line of ERD

Reconciling the MDGs with new global challenges the EU's approach

- How global changes (new geo economics, China, India, Afghanistan, security threats, migration, environmental degradation, climate change, etc) affect the development agenda?
- The European flavour - EU approach is based on values, norms and interests/ Europe's experiences as a governance system/poverty eradication does not only mean economic growth but also political and social aspects (democracy, inequality, well-being,..)
- What will be Europe's role in this new global context?
- First report will focus on Africa

Governance Structure (2)

- Management/Steering Committee: made of representatives from EU Member States, the European Commission and the European research community; it provides leadership and vision
- Task Force: composed of the Commission and researchers from contributing Member States; drafted the first proposals
- A research institute/consortium will be in charge of managing the ERD Team, permanent writing and editorial team, responsible for the content of the report and its overall quality, coherence and timeliness
- ERD Secretariat: based in the Commission, DG Dev; coordination role and links with policy making structures
